7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **Specified date and time mentioned above** at the office of Kathmandu Metropolitan City. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amount shall be valid for (minimum 120 Days) 30 days beyond the validity period of the bid .
